- ii) Water is muddy from all of the rain.
- iii) Another water treatment is supposed to take place next week.
- iv) Need to add more rocks for filtration due to all the water drainage. Beach area could also use sand. There is no budget or amount attached to it.
- v) Would like to add the reason why we don't like fishing at the beach lot to the sign.

b) Park Committee

- i) Larry Asking for scissor lift to clean bird nests at the beach lot. GT Also add bird netting around the caging.
- ii) TC will post on Facebook asking for assistance. If not, then we will look into cost. WM cost may be around \$250 per day.
- iii) Also looking for signs to clean up dog poop.

c) Road Repair Committee

i) TH would like to pass off the committee chair position to someone else. TH would like to stay on the committee. Has someone in mind but they have not committed yet.

a) Mindy Ritter

- i) Social Committee was present in previous years. Mindy would like to reinstate it and be the social committee person.

- c) Chase Bank recommended an app calls "zelle" it's guaranteed funds app. This is a free service. Only downside that if someone sends money and doesn't indicate what property the funds are for it could be an issue. If the Board decides to go this route we need to put specific instructions in as to how to use the site. Homeowner does not need to have a chase account.

Update

August 13 – From Wes via email – "I did receive a call back today from our representative at the insurance company. She was not familiar specifically with Zelle, but indicated that we would have to see if they assume financial responsibility for their transactions. In either case (whether they do or don't) she would recommend that if we were going to move forward with this, she could provide us with a quote. She asked for the annual dues amount and number of households in the HOA, and thought that this would be a minimum of \$500 annually. It could be as much as \$1000. Given this, and the fact that the payments are tied to an email or phone number, neither of which we currently track (my opinion

would be that this would make it harder for me to track payments), my vote would be to NOT pursue this further".

Board agreed unanimously not to move forward with Zelle.
