Santa Visits



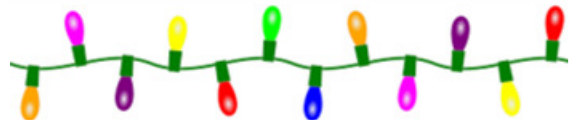
Santa Claus will be in the FBCA neighborhood on December 10th.

- **No motor vehicles, (no snow mobiles)** are permitted on the lake. Anyone in violation of this rule will be reported to the White Lake Police and ticketed.
- Any construction (fencing, decks, dog runs, sheds, home additions, etc.) must be approved by the Board **PRIOR** to the start of any building. If not, you may have to remove any structure not approved at your cost.
