Road Update

A group of concerned residents (not the HOA) has been working to get certain roads repaved in Fox Bay. The Special Assessment District (SAD) for improving the roads on Vanden, Huron River Dr., Maria, Fox Bay, Huron River Court and Perry received enough signatures to qualify to proceed to the next planning stages.

After holding an objections hearing on August 23, the Road Commission of Oakland County (RCOC) did not receive an objection petition and the project is now officially approved. Road improvements should begin mid-year 2024!
